Dr. Ganguli is an Assistant Professor of Medicine, health services researcher, and a practicing primary care physician at Harvard Medical School and Brigham and Women's Hospital. She received her AB, MD, and MPH from Harvard University and completed internal medicine/primary care residency and health policy and management fellowship at Massachusetts General Hospital. Her research focuses on the payment, delivery, and value of primary care, the use and consequences of low–value care, and gender equity. Dr. Ganguli serves as an Associate Editor at JAMA Network Open. She is also a former journalist who has written about science and health care for The Boston Globe, Reuters, The New York Times, and The Washington Post, among other publications.

Clive Fields, MD
Co–Founder and Chief Medical Officer, VillageMD

As Chief Medical Officer and co-founder of VillageMD and an esteemed practicing physician, Clive Fields, M.D., is transforming the way today's patients and physicians experience health care. Dr. Fields helped create VillageMD in 2013 to enable progressive physician groups, independent practices and health care organizations to move toward a primary care–led, high–value clinical model with improved quality, exceptional patient experiences and lower costs. Under Dr. Fields' co–leadership, VillageMD has grown from an initial practice of 13 physicians to a partnership with more than 3,000 physicians across 19 markets who are responsible for approximately 1.6 million lives.

Dr. Fields has demonstrated a passion to deliver value—based care throughout his medical career. His dedication and contributions culminated in his receiving the 2018 Robert Graham AAFP Physician Executive of the Year by the American Academy of Family Practice's (AAFP). He is consistently named one of Houston's "Top Doctors" by H Magazine and Texas Monthly. Most recently, Dr. Fields was recognized by Modern Healthcare as of the 50 most influential clinical executives for 2020.

In the early 1990s, prior to beginning VillageMD, Dr. Fields initiated and served as president of Village Family Practice, which became one of the largest primary care groups in Houston and was recognized for its quality of care by the Centers for Medicare and Medicaid Services (CMS) and the National Committee for Quality Assurance (NCQA).

Despite his leadership roles and commitments, Dr. Fields makes patient care his ultimate priority. He sees patients weekly and serves on staff at Memorial Hermann Memorial City Hospital, The Methodist Hospital and CHI St. Luke's Health–Baylor St. Luke's Medical Center. Dr. Fields also functions as an Associate Professor of Family Medicine at both Baylor College of Medicine and the University of Texas at Houston. An active member of the AAFP, he is a regular contributor on health care topics for leading publications including Forbes, Health Data Management and the Houston Chronicle. Dr. Fields received his medical degree from The Chicago Medical School and his bachelor's degree from The University of Texas at Austin.

For Dr. Fields, health care is about pioneering improvements in care to improve the lives of patients and expand the abilities of the physicians who serve them every day

Dr. Elizabeth Fowler is the Deputy Administrator and Director of the Center for Medicare and Medicaid Innovation at CMS. She was special assistant to President Obama on health care and economic policy at the National Economic Council. In 2008–2010, she was Chief Health Counsel to Senate Finance Committee Chair, Senator Max Baucus (D–MT), where she played a critical role developing the Senate version of the Affordable Care Act. She also played a key role drafting the 2003 Medicare Prescription Drug, Improvement and Modernization Act (MMA). Dr. Fowler has over 25 years of experience in health policy and health services research. She is admitted to the bar in Maryland, the District of Columbia, and the U.S. Supreme Court. Dr. Fowler is a Fellow of the inaugural class of the Aspen Health Innovators Fellowship and a member of the Aspen Global Leadership Network.

Ms. Erickson currently serves as Chief Advocacy Officer and Senior Vice President of Governmental Affairs and Public Policy with the American College of Physicians (ACP). In this role, Ms. Erickson oversees the operations of the Washington, DC office and manages ACP's overall advocacy and policy initiatives relating to Congress and federal regulatory agencies, including the Department of Health and Human Services (HHS), Centers for Medicare and Medicaid Services (CMS), CMS' Center for Medicare and Medicaid Innovation (CMMI), and other federal bodies. Ms. Erickson also oversees ACP's Department of Medical Practice, which is responsible for the ongoing development and maintenance of programs, products, tools, and services to assist medical practices with regulatory compliance and practice transformation. Kristen McGovern has been at the forefront of federal health care policy and politics for more than a decade. Dr. Perrin was founding editor of Academic Pediatrics. He has studied asthma, middle ear disease. children's hospitalizations, health insurance, and childhood chronic illness and disabilities. A recent focus has addressed improving Medicaid for younger people in Massachusetts and nationally. He received a Robert Wood Johnson Foundation Investigator Award in Health Policy Research and was a member of the Agency for Healthcare Research and Quality National Advisory Council. He is an elected member of the National Academy of Medicine. He has been on several national committees relating to children and youth with special health care needs and their families, including with the National Academies' Board on Children, Youth, and Families. He currently co-chairs a NASEM committee on child and adolescent health care transformation. He has served on the boards of Family Voices, the Frank Porter Graham Child Development Institute (University of North Carolina), and the Institute for Exceptional Care. He graduated from Harvard College and Case Western Reserve School of Medicine, followed by residency and fellowship at the University of Rochester and had faculty appointments at Rochester and Vanderbilt. While at Rochester, he developed a community health center in rural communities between Rochester and Buffalo.

Tom Wroth, MD CEO, Community Care of North Carolina (CCNC)

Dr. Wroth is a practicing family physician and CEO of Community Care of North Carolina (CCNC). CCNC is one of the nation's longest running medical home programs and now supports over 500 independent practices caring for 1.2M patients in value based contracts. Dr. Wroth is the former Chief Medical Officer at Piedmont Health, a system of 10 FQHCs and 2 PACE sites. He was previously on faculty in the Department of Family Medicine at the University of North Carolina at Chapel Hill. Dr. Wroth trained in Family Medicine and Preventive Medicine at UNC Chapel Hill and attended medical school at Columbia University, College of Physicians and Surgeons.



Bennett Graham serves as President and Co-Founder of Main Street Health. Main Street Health is a value-based healthcare company focused exclusively on serving rural communities. Main Street successfully launched in 2021 with funding from Oak HC/FT, Frist Cressey Ventures, and Russell Street Ventures.

Prior to Main Street, Bennett most recently served as a General Manager within Anthem's Diversified Business Group where he built a full-risk, capitated care model focused on patients with the greatest needs in a collaboration between Aspire Health and CareMore Health. Bennett also served as Senior Vice President of Operations at Aspire Health, where he scaled the operations to support 10x revenue growth across 25 states.
